1. Under the authority established by the references, the Armed Forces Disciplinary Control Board (AFDCB) unanimously voted the following establishments/organizations off-limits to all military personnel of the Tri-Command.

2. Enclosure (1) contains establishments/organizations in and around Fort Stewart, GA that are considered off-limits to military personnel by the CG, 3rd Infantry Division/Fort Stewart.

3. All military personnel from the Tri-Command that patronize or receive services from any of the above named and enclosed establishments are subject to disciplinary action under the Uniform Code of Military Justice. The Tri-Command includes Marine Corps Recruit Depot/Eastern Recruiting Region, Parris Island; the Marine Corps Air Station, Beaufort; and the Beaufort Naval Hospital.

4. This off-limits order is a measure taken in response to confirmed reports of conditions which adversely affect the safety, welfare, and the good order and discipline of the Armed Forces. The seriousness of these reports requires this immediate action.

5. This order is in effect immediately and will remain as such until measures are taken by the owners of the listed establishments to fully address AFDCB questions regarding Tri-Command military personnel safety and welfare.

6. I request commanders ensure widest distribution of this order.



Military personnel who violate AR 190-24/AFI 31-213/OPNAVINST 1620.2A/MCO 1620.2D/COMDINST 1620.1E by using, visiting, or entering these business establishments are subject to disciplinary action under the Uniform Code of Military Justice (UCMJ).

3. An off-limits area is defined as any vehicle, conveyance, place, structure, building, or area prohibited to Active Duty Armed Forces to use, ride, visit, enter, or conduct business with during the period in which it is declared off-limits.

4. Commanders will ensure all members of their command are aware of this list.
