Subj: DEPOT POLICE, BUILDINGS AND GROUNDS MAINTENANCE

1. Situation. The term Responsible Organization (RO) is the organization responsible for the overall supervisory management of the facility (ies) and of its occupants as assigned to their organization by this order. They are also responsible to ensure the overall upkeep, security, police, and maintenance is completed by the occupant/user. The occupant/user is a group or organization assigned the facility (ies) for use through an RO.

2. Cancellation. DepO 11014.8P

3. Mission. All units and tenant organizations will take actions daily to ensure a clean, neat and orderly appearance of roads, grounds and buildings at Marine Corps Recruit Depot (MCRD) Parris Island.

4. Execution

a. Commanders Intent and Concept of Operations

(1) Commander's Intent. Our mission of recruiting and making Marines relies on the readiness of our buildings, training facilities and base infrastructure. Our mission and location is also linked to the increasingly high number of military personnel, civilians and retirees that visit Parris Island every week, logging over 130,000 visitors per year. The purpose of this order is to ensure our buildings and base support facilities are kept in the highest state of readiness,

and the Depot is maintained with a clean and neat appearance at all times. We will accomplish this by outlining roles, responsibilities and tasks between the Facilities Maintenance Division (FMD), Depot training and support units, and support organizations such as Marine Corps Community Services (MCCS). The end state is for all military and civilian personnel to take pride and ownership in their buildings and grounds so that we quickly identify and repair maintenance discrepancies, clean-up trash and litter, and maintain our landscape in showcase condition.

(2) Concept of Operations. All personnel, military and civilian, will maintain a high standard of police and maintenance of buildings and grounds aboard the Depot. The provisions of this order shall guide commanders and staff officers in the performance of their duties. Recipients of this order will thoroughly familiarize themselves with the provisions contained herein, and will comply with its procedures.

b. Subordinate Element Missions. Organizational commanders are responsible for ensuring that occupants of facilities assigned to their care maintain those facilities and adjoining grounds in a high state of serviceability, as would be expected of prudent homeowners. General responsibilities common to all include:

(1) Commanders must maintain overall responsibility for the exterior police of their designated areas as set forth in this order.

(2) Protecting facilities and grounds from malicious damage and vandalism.

(3) Restricting the use of vehicles on grassed areas except when absolutely necessary.

(4) Reporting maintenance and repair problems to the Facilities Maintenance Division through organizational S-4 offices in a timely manner, and conducting periodic reconciliations with FMD.

(5) Appointing responsible personnel (usually within the S-4 sections) to serve as maintenance coordinators with the Facilities Maintenance Division.

(6) Tenants of all buildings are responsible for housekeeping care. Such janitorial duties include, but are not

limited to: cleaning of floors, walls, windows (inside and outside), cleaning of fixtures and various Marine Corps-owned appliances, such as window air conditioners, refrigerators, washing machines, dryers, water fountains, etc. Janitorial supplies such as floor wax, cleaners, light bulbs and fluorescent tubes are tenant responsibilities. Fluorescent fixtures that are inaccessible, or not working due to unavailable tube size or ballast failure, should be reported to Facilities Maintenance for repair or replacement. Tenants are not authorized to use pressure washers inside a facility for any reason. Pressure washing for the outside of facility should only be done as needed to remove mildew - pressure washing is a tenant responsibility and equipment should be requested from FMD. This instruction does not authorize the purchase of unit pressure washers.

(7) Tenants are responsible for the police of grounds, sidewalks, parking areas and streets adjacent to their buildings as listed in enclosure (2). This includes leaf raking, shrubbery maintenance, and the emptying of small trash/litter containers into available dumpsters. Additionally, picnic areas located on grounds adjacent to their buildings should be considered part of their responsibility. Picnic equipment should be checked weekly, at a minimum, to include cleaning of grill cooking surfaces. Any needed repairs noted during weekly checks should be submitted to FMD via a standard work request.

(8) Unit-specific responsibilities are (but are not limited to):

(a) Commanding Officer, Headquarters and Service Battalion

1. Responsible for the special areas of interest as assigned in enclosure (2).

2. Responsible for trimming/pruning of shrubs, mowing/edging of grass and daily police of all buildings and facilities assigned in enclosure (3).

3. Responsible for providing after hours (weekdays 1700-2000 and on weekends between 0800-1200 and 1700-2000) motorized police call on a daily basis for the below two areas:

a. Begin motorized police call at the intersection of Malecon Drive and Wake Blvd. Proceed west toward the traffic circle, to include the picnic areas, and

around the Traffic Circle. Once the Traffic Circle is complete, proceed out the main gate and down the General Pollock Causeway to the old main gate and then reverse course and proceed back towards the main gate and around the Traffic Circle. Make a right on to 3rd Battalion Pond Road to Wake Boulevard.

b. Make a right on Wake Boulevard then a left on Yorktown Blvd, turn right on St. Mihiel Rd towards Elliot's Beach. Ensure the picnic area is police-called. Leaving Elliot's Beach, police call Yorktown Blvd toward the ASP. Continue to police call toward the picnic area past "DI" Bridge. Make a left on to Chosin Reservoir Rd, and police call past the DCAC Building and the sports fields. Make a right on Samoa Street, and another right on to Blvd de France. Make a right on Mexico Street, followed by a left on Tripoli Street. Continue to police call, stopping at the NCIS pier and picnic area.

(b) Commanding Officer, Recruit Training Regiment
(RTR)

1. Responsible for the special areas of interest as assigned in enclosure (2).

2. Responsible for trimming/pruning of shrubs, mowing/edging of grass and daily police of all buildings and facilities assigned in enclosure (3).

3. Responsible for the cleaning and upkeep of the restrooms, as well as the service area at Peatross Parade Deck, with the aid of the graduating Battalion's S-4 and Team Week Recruits.

4. Responsible for the general upkeep of the reviewing stand and guest bleachers, with the aid of the graduating Battalion's S-4 and Team Week Recruits.

5. Responsible for providing cleaning supplies and hygiene materials for the Visitor's Plaza heads and covered area and ensure that they are policed, cleaned and inspected daily. Special consideration and attention should be applied during designated Commanding General's Visitor's Days (typically Wednesday through Friday) during graduation weeks. Ensure that maintenance requests are submitted for all broken or damaged facilities at the Visitor's Plaza.

6. During Team Week, when recruits are not available, provide personnel from Recruit Separations Platoon or Basic Marine Platoon to AC/S G-4 in support of motorized patrols.

7. Responsible for the police and the trimming/pruning of shrubs and mowing/edging of grass around recruit barracks at Weapons and Field Training Battalion; Buildings 737, 738, 739, 751, 7001, 7003 as well as the temporary barracks when they are occupied by training companies.

8. Properly police hike routes upon completion of training.

9. When available, provide recruits to HQSVCBn S-4 to assist in the upkeep of Barrow Hall.

10. Provide hygiene items and cleaning equipment and supplies to sustain recruit populations while training at Weapons and Field Training Battalion (rifle ranges, etc. Ensure that areas occupied for training while aboard Weapons and Field Training Battalion are inspected and policed daily and that all broken and damaged facilities are reported immediately to WFTBn S-4.

(c) Commanding Officer, Weapons and Field Training Battalion.

1. Responsible for the special areas of interest as assigned in enclosure (2).

2. Responsible for ensuring that rifle range heads are cleaned by the using unit NLT COB of qualification day as well as the special area of interest as assigned in enclosure (2).

3. Responsible for providing cleaning supplies for rifle range heads and ensuring that they are cleaned by the using unit no later than close of business of qualification day as assigned in enclosure (2).

4. Responsible for trimming/pruning of shrubs, mowing/edging of grass and daily police of all buildings and facilities assigned in enclosure (3).

5. Responsible for grass cutting, trimming and edging of firing lines on all ranges.

6. At Paige Field, responsible for the maintenance of obstacles, grounds, and courses directly related to the Crucible events. Responsible for the 1st echelon maintenance of the Endurance Course events (sand/mulch/ruts). FMD is responsible for the upkeep/repair of the Endurance Course obstacles and trail.

(d) Tri-Command Military Housing

1. Responsible for refuse removal from personal quarters and housing recreation areas.

2. Responsible for instructing/enforcing resident requirements for grounds maintenance.

3. Responsible for maintaining common areas in housing developments.

4. Responsible for scheduling street cleaning and debris removal from sewer drains in housing areas.

(e) Marine Corps Community Services (MCCS)

1. Responsible for the special areas of interest as assigned in enclosure (2).

2. Responsible for trimming/pruning of shrubs, mowing/edging of grass and daily police of all buildings and facilities assigned in enclosure (3).

(f) Occupants of family housing. Responsible for the police of areas adjacent to assigned quarters in accordance with reference (b).

(g) Depot Officer of the Day. Prior to 0900 on weekends and holidays and after 1630 on normal workdays, inspect the state of police aboard the Depot. Discrepancies found in areas within this order are to be directed to the appropriate Officer of the Day for corrective action.

(h) Provost Marshall Office

1. Assist with locating the owners of vacant and/or "abandoned" vehicles, and those vehicles that are illegally parked; such as but not limited to: boats, RV Campers, and other recreation vehicles.

(i) All Depot Personnel. When appropriate, take immediate action to correct discrepancies with regards to area police and report building and grounds maintenance discrepancies to the respective Command Duty Officer if the discrepancy observed cannot be corrected by immediate action.

c. Coordinating Instructions

(1) The execution of an effective facilities maintenance management program is dependent upon the full support, cooperation, and assistance provided by the tenants which it supports. This support can best be achieved through proper coordination and liaison between the Facilities Maintenance Division Director and the representatives of the tenant commands utilizing the organization's chain of command structure. This process allows all levels within the chain of command to be aware of their respective maintenance requirements, and supports Facilities Maintenance by reducing the number of authorized requesters to a minimum.

(2) Routinely, the preparation of the written work request originates with the command S-4, who will sign/initial and date the request prior to forwarding the request to Facilities Maintenance.

(3) All dining facility repair requests will be submitted by the Depot Food Service Officer.

(4) Command S-4's should maintain a copy of all written work requests submitted to FMD via MAXIMO, and a log with ticket numbers for all phone requests. Work requests should be reconciled weekly.

(5) Occupants of buildings are responsible for the inside and outside appearance of the facility. Police of buildings and grounds maintenance responsibilities include the following:

(a) Mowing and edging of grass in improved areas to maintain a satisfactory appearance. Edging should be done in such a manner as to avoid creating a "ditch". Edges should be flush with the sidewalks and curbs.

(b) Pruning and trimming of shrubbery and removal of unsightly plant growth around Depot facilities.

(c) Identification to G-4 of trees in need of pruning.

(d) Police of areas (to include properly disposing of both organic and inorganic debris) to improve the appearance of the Depot.

(6) The Assistant Chief of Staff, G-4, is responsible for the assignment of all buildings and grounds, as appropriate, to subordinate commands or organizations in accordance with reference (a). Such assignment carries with it the responsibility for police, buildings and grounds maintenance.

(a) In addition, the AC/S G-4 Operations office will ensure compliance with this order and references via the use of a daily patrol.

(7) Facilities Maintenance Division Director will maintain cognizance and responsibility for performing police and grounds maintenance of common areas, which includes all areas not assigned to subordinate commanders and general/special staff sections. This includes controlling and emptying dumpsters located throughout the Depot.

(8) The Resident Officer in Charge of Construction (ROICC) will maintain cognizance and responsibility for the police of areas in which contractors are working.

(9) Discarding of trash in any form to include organic debris, foodstuffs, paper, plastics, glass, and metal along roadways or on any grounds aboard the Depot is prohibited. The Depot dumpsters/roll-offs and contractor roll-offs will not be used to dispose of trash from individuals' homes.

(10) Buildings and grounds maintenance and police responsibilities will be specifically included in all host-tenant and inter-service support agreements.

5. Administration and Logistics

a. AC/S G-4 has overall quality control for the management, coordination, and inspection of the police and buildings and grounds maintenance aboard the Depot.

b. Discrepancies or questions in area police responsibilities aboard the Depot are to be brought to the attention of AC/S, G-4 Operations office at 4565 for resolution.

c. Reference (a) provides additional guidance for this order.

d. Submit all recommendations for this order via Naval format letter to AC/S G-4.

6. Command and Signal

a. Command. This order applies to all personnel, commands, tenants, and activities aboard Marine Corps Recruit Depot Parris Island, South Carolina.

b. Signal. This order is effective the date signed.

Definitions

1. Police. The removal and proper disposal of both organic and inorganic debris to improve the appearance of the Depot.
2. Police and Grounds Maintenance. Extends to the nearest street, parking lot or midway to the nearest building, including spaces confined by fences and other enclosures, but no more than 125 feet (or to the street) from their respective work space or building. Spaces that are across a street, and are not improved, will be policed and maintained by the unit having closest proximity to it. The Assistant Chief of Staff, Installations and Logistics (I&L), will resolve questions concerning degree of responsibility.
3. Improved Grounds. Defined as grounds on which extensive development and maintenance measures are required to obtain a pleasing appearance. Grass in these areas should not exceed a height of four inches.
4. Semi-Improved Grounds. Defined as grounds that have a stand of grass to prevent erosion and require periodic maintenance to control growth of weeds and brush and reduce fire hazards.
5. Unimproved Grounds. All other unpaved areas not included in the improved or semi-improved categories and on, which no scheduled maintenance is performed. Included are forest management areas and tidal marshes.
6. Other Grounds. Areas occupied by buildings, streets, parking areas, sidewalks, and other paved areas.

Policing Responsibilities for Special Areas of Interest by Unit

Headquarters and Service BN

1. Picnic area at DI Bridge.
2. Boulevard de France-from Samoa St to Wake Blvd.
3. Malecon Drive-from Traffic Circle to Wake Blvd.
4. Horse Island picnic area and head facility.
5. Third Bn Pond Rd-from Horse Island Circle to Wake Blvd.
6. NCIS Pier.
7. Along Chosin Reservoir Rd from Santo Domingo St to Cuba St.
(this includes both sides of road).
8. Scout Island picnic area.

Weapons and Field Training BN

1. Weapons and Field Training Bn Boat Dock (Horse Island).
2. Wake Blvd-from Yorktown Rd throughout Battalion area.
3. Boat ramp at Generals Landing (E-Beach).

Recruit Training Regiment

1. Wake Blvd (from Farm Rd to Blvd De France to include wooded area across from 3rd Bn Recruit Barracks).
2. Parade Deck and Adjacent Areas (Specifically the guest heads behind the reviewing stand, the seating area around the parade deck and the area between the All Weather Training Facility and the parade deck).
3. Recruit Head Facility at Elliot's Beach.
4. Sidewalks and roadways along Shanghai St., Panama St. and Farm Rd.
5. Molly Marine Monument.

1. All Picnic areas aboard the Depot not specifically assigned to other units. Includes the lawn care around the Visitor's Plaza.
2. Fishing Piers on Third Bn Pond Rd.
3. Chosin Reservoir Rd (from Samoa St. to Santo Domingo St.) to include Softball Fields and wooded area across Chosin Reservoir Rd.
4. Elliott's Beach Recreational Area (including the head and picnic shelters).
5. Community Center and Rod and Gun Club area.
6. Belleau Wood Road (From Yorktown to Golf Club House; Portion of this area will also be covered by RTR Hike route).

Provost Marshall Office

1. Main Causeway-from old front gate to Traffic Circle.
